This information note describes the way in which we collect and use the personal data collected through this website or our accounts from the social media networks.

**From where we collect information about you**

Any personal data you provide us through our website, our social media accounts or collected during the attendance to events organized by DDS Romania & CSCD shall be processed exclusively for the intended purpose, according to the herewith document. In addition, we shall use this information to update our database and we will send you, as allowed by the law, occasional offers and we will inform you about new products, services and other elements which could be of interest to you.

**How we use personal data**

Please find below the purposes for which we process your personal data, the persons that have access to your data, as well as the manner in which we store them:

In order to be easier to follow, we have detailed the DDS Romania & CSCD data processing in two different sections:

- Section I - Registration to the events organized by DDS Romania & CSCD

**1. In order to attend the Legends Global Event we need your information to perform the registration.**

When register on the DDS Romania & CSCD Congress website, you shall be automatically generated an account as a result of filling in the registration form to the Legends Global Event.

In case you request additional information or support for registering to the event, we shall have to process some of your information.

Also, we shall process your information in order to send important information about the event you registered to, about the partners of this event or about other events the DDS Romania & CSCD Associations shall organize. We shall stick strictly to the information we consider could be of great interest.

<p>For how long we will store the information</p>	<p>We shall not keep the data you send for more than 18 months from the last event you attended, except the financial and accounting documents which will be kept in the archive for 5 years, starting from the conclusion of the fiscal year when they were drafted, according to the periods of the Accounting Law no. 82/1991 and of the Order 2634/2015</p>
<p>Where is the information stored</p>	<p>The information sent through the website <a href="https://legends.dental">legends.dental</a> or the virtual platform shall be stored on the hosting supplier's servers, located in the European Union.</p>

**Important:**

In case during the registration of the events personal data related to you were found and you wish for them not to become public, please inform us promptly so we can remove that information from the events’ pictures/records.

**2. When you contact us through social networks and share information from the website**

Every time one of our users shares information from our websites through buttons integrated from social networks, DDS Romania & CSCD is liable together with that social network for that processing.

It is the liability of DDS Romania & CSCD and of the social network (as associated collectors) to process the personal data shared between us and the social network (for example, cookie ID).

### 3. Facilitating an easy and pleasant surfing on our website

When you access our website, we collect data about you through online identifiers (cookies and IP).

The website automatically collects some information and stores it in journal files.

We use this information to design our website in order to adapt better to our users' needs. Also, we might use your IP address to help diagnose the possible malfunctions of our servers and to manage our website, to analyse the tendencies, to track the movements of the visitors and collect general demographic information, to help identify the preferences of the users.

#### **Is the data collected and processed by DDS Romania & CSCD in safety conditions?**

We have implemented physical, electronic and management security measures to protect and guarantee the information we collect and process.

But please recall that unfortunately no data transmission is 100% guaranteed.

**Important:** After the completion of the information storage period, your information shall be erased. In case we think this data could help us improve the quality of our products or services, we will continue to use this data only after this data irreversibly becomes anonymous.

#### **The processing of personal data of underage people**

The website [legends.dental](http://legends.dental) does not willingly collect information from children under 18. The access and use of the website by underage people represents the implicit approval of the legal guardian for the browsing of our website by the dependant underage. Also if we discover that an underage person has used our website without the approval of his/her legal guardian, we shall erase all the related personal data.



## The rights you have

As targeted person you have specific legal rights regarding your personal data we collect and process. **DDS Romania & CSCD** respects your rights and assures you will specifically take your interests into account.

- **Data correction:** In case you notice we have wrong personal data, you can request us at any time to correct your related personal data. We make reasonable efforts to keep your personal data - which is used continuously or is in our possession or control - accurate, complete, current and relevant, based on the most recent information available for us.
- **Restriction of the processing:** In case you are in one of the below situations you can request us to restrict the processing of your data:
  - challenge the correctness of the personal data for the period in which we must check the accuracy,
  - the processing is illegal and you request restricting the processing rather than erasing personal data,
  - we no longer need your personal data, but you request them to establish, perform or defend a right, or
  - You oppose the processing in the period in which we check if our legitimate reasons have precedence over your rights.
- **Access to your information:** You can request information about the personal data we have about you, including information regarding the data categories, what they are used for, where we collected them, if they are collected directly from you and to whom they were disclosed, if applicable. You can obtain a copy from us, free of charge, of the personal data we have about you. We reserve the right to charge a reasonable tax for abusive requests.
- **Portability right:** Upon request, we shall transfer the personal data to another operator, where technically possible, provided the processing is necessary for the performance of an agreement. Rather than receive a copy with your personal data, you can request the transfer of the information directly to another operator, mentioned by you.
- **Cancellation right:** You can obtain from us the cancellation of the personal data, in case:
  - your information is no longer necessary in relation to the purposes for which they were processed;
  - you have the right to oppose to the subsequent processing of personal data (see Opposition right below) and exercise this objection right upon processing;
  - the personal data was illegally processed;

Except the case in which the processing is necessary

- in order to comply a legal obligation which needs processing by us;
  - especially for the data keeping legal requirements;
  - to establish, exercise or defend a right.
- **Opposition right:** You can object at any time to the processing of the personal data due to the special situation you are in. In this case, we shall no longer process personal data, unless we can prove solid, legitimate reasons and a major interest in the processing or in establishing, exercising or protecting a right. When you oppose the processing, please mention if you want the cancellation of the personal data or the restriction in processing this information.
  - **The right to file a complaint:** In case of an alleged infringement of the legislation in force related to confidentiality, you can submit a complaint to the national supervisory authority for personal data protection:

**To remember!**

**Period:** We shall try to solve your request within 30 days. However, the period can be extended for reasons related to the specific legal right or the complexity of the request.

**Restricting the access:** In certain situations we might no longer be able to grant access to a part or all personal data, because of restrictions provided by the law. If we deny the access request, we shall communicate the reason for the refusal.

**Identification impossibility:** In some cases we might not be able to identify the personal information because of the lack of identification elements supplied in the request you send. In such cases, if you do not supply additional information that allows your identification, we shall not be able to honour the request of exercising the legal rights as described in this section.
